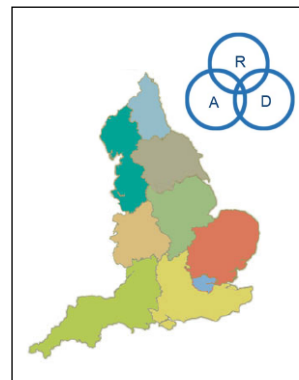


ESOL- A New Approach

Regional Achievement Dialogue (RAD)
